

### PFAS Remark :

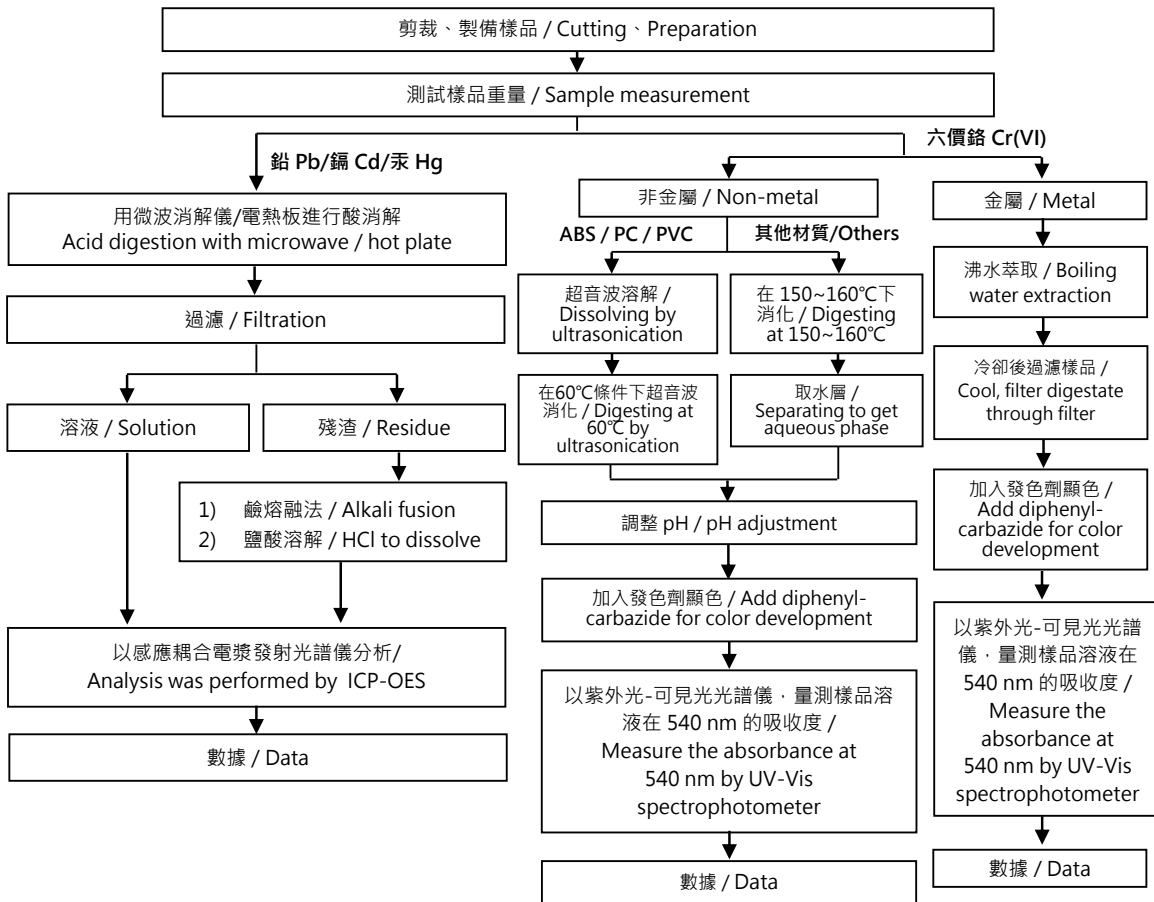

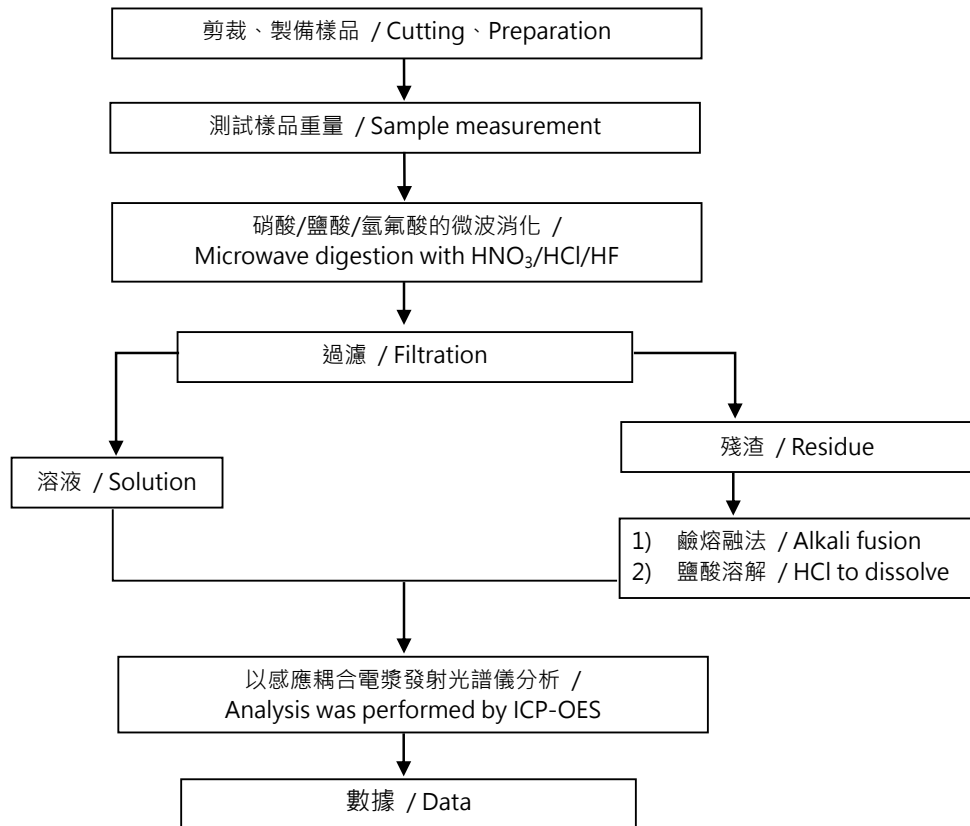
